राष्ट्रीय शैक्षिक अनुसंधान एवं प्रशिक्षण परिषद (NCERT) केंद्रीय विद्यालय, नवोदय विद्यालय, राज्य शिक्षा विभागों और गैर सरकारी संगठनों के शिक्षकों एवं प्रमुख कर्मियों के लिए दूरस्थ और प्रत्यक्ष माध्यम के संयोजन के साथ "मार्गदर्शन एवं परामर्श" विषयक डिप्लोमा पाठ्यक्रम (कोर्स) प्रदान कर रहा है. जनवरी 2024 से दिसंबर 2024 तक विस्तृत ये पाठ्यक्रम तीन चरणों में सम्पादित किया जायेगा.

प्रथम चरण - निर्देशित स्वशिक्षा (गाइडेड सेल्फ लर्निंग) (6 महीने, जनवरी - जून, 2024).

**दवितीय चरण**- अध्ययन केंद्रों पर पूर्णकालिक गहन व्यावहारिक संपर्क कार्यक्रम (3 महीने, जुलाई - सितंबर, 2024).

तृतीय चरण- कार्यस्थल में इंटर्नशिप (3 महीने, अक्टूबर - दिसंबर, 2024).

पाठ्यक्रम का उद्देश्य विद्यार्थियों के समग्र विकास को बढ़ावा देने एवं उनकी शैक्षणिक, सामाजिक-भावनात्मक और नैतिक विषयों के प्रबंधन के लिए शिक्षकों के कौशल और दक्षताओं को बढ़ाना है.

योग्य उम्मीदवारों को शैक्षिक मनोविज्ञान एवं शिक्षा आधार विभाग (DEPFE) नई दिल्ली, राष्ट्रीय शिक्षा संस्थान (NIE) नई दिल्ली और अजमेर, भोपाल, भुवनेश्वर, मैसूरु और शिलांग में स्थित क्षेत्रीय शिक्षा संस्थानों में प्रवेश की पेशकश की जाएगी. प्रत्येक केंद्र पर स्थानों की अधिकतम संख्या 50 होगी. सरकारी प्रतिनियुक्त उम्मीदवारों को प्राथमिकता दी जाएगी. आवेदनों की स्क्रीनिंग के लिए आवेदन की अग्रिम प्रति पर विचार किया जाएगा. प्रवेश के सन्दर्भ में राष्ट्रीय शैक्षिक अनुसंधान एवं प्रशिक्षण परिषद (NCERT) का निर्णय अंतिम होगा. इस संदर्भ में राष्ट्रीय शैक्षिक अनुसंधान एवं प्रशिक्षण परिषद संलग्न है.

**Sub**.: Admission Announcement by NCERT for Diploma Course in Guidance and Counselling, 2024-reg.

NCERT offers the diploma course in Guidance and Counselling with a combination of distance and face-to-face modes for teachers, teacher educators and key personnel from KVS, NVS, State Education Departments, and NGOs from India. The course will be offered from January 2024 to December 2024. The course is Spread over three phases:

**Phase I** - Guided Self Learning (6 months, January – June, 2024).

**Phase II**- Intensive Practicum, full time contact programme at study centers (3 months, July – September, 2024)

**Phase III**- Internship in candidate's hometown/workplace (3 months, October – December, 2024).

The course aims at enhancing the skills and competencies of teachers to promote holistic development of pupils and handle their academic, socio-emotional, and ethical problems.

Admission to eligible candidates will be offered at Department of Education Psychology and Foundation of Education (DEPFE) New Delhi, National Institute of Education (NIE), New Delhi and Regional Institutes of Education located at Ajmer, Bhopal, Bhubaneswar, Mysuru and Shillong. Maximum no. of seats at each center will be 50. Government deputed candidates will be preferred. Advance copy will be considered for screening of applications. NCERT's decision will be final in matters of admission. The NCERT notice is enclosed for reference.

All applications should be submitted only online and no applications will be accepted in the department or on E-mail. The applications will be sorted and duly sent to regional study centers as per the rules of the Diploma.

## Admission Brief Diploma Course in Guidance and Counselling (2024)

The increasing complexities and stresses of modern day living, everyday reports of lack of interest in studies, low achievement, truancy, aggression, behavioural problems, suicide, drug abuse and the like call for provision of guidance and counselling for children and youth in schools. Teachers and other school personnel need to equip themselves with helping skills to promote students' personal, social, educational, career development and adjustment throughout the school years.

Mental health concerns have been addressed by the National Education Policy (NEP), 2020. The involvement of well-trained social workers, counsellors, and community involvement into the schooling system has been emphasised to optimise student's learning. Mental health issues among individuals have been a rising concern. The National Education Policy (NEP), 2020 puts fourth this concern and highlights the urgent need for ensuring "not only cognitive development, but also building character and creating holistic and well-rounded individuals equipped with key 21st century skills". This, however, requires professional orientation and training.

In this context, NCERT is offering a Diploma Course in Guidance and Counselling. The course of one-year duration with a unique blend of distance and face-to-face modes is open to candidates from India. Candidates from different regions of India will be admitted at DEPFE, NIE, New Delhi and Regional Institutes of Education at Ajmer, Bhopal, Bhubaneswar, Mysuru and Shillong. Applications are invited online for admission to the course from the eligible candidates.

#### Target group

#### **Eligibility**

In-service teachers / teacher educators / untrained guidance personnel/ school administrators

- In-service teachers— graduates with teaching degree.
- Candidates 'presently not working' graduation with teaching degree and at least two years of teaching or related experience.
- Postgraduates in psychology /education /social work / child development/special education. Preference will be given to those with at least one year of teaching or related experience.

Minimum % of marks for all target groups is 50% (5% relaxation for SC/ST).

No. of seats

Maximum 50 per study centre. Reservations apply as per the Government of India norms.

**Duration and phasing** 

One-year, from January to December\*

Guided Self-Learning Six Months (Distance)
Intensive Practicum\*\* Three Months (Face-to-Face)
Internship Three Months (in Home Town)

\*During distance learning phase, tutorials (once a month of two days duration/every two months of five days duration) will be organised at all study centres and learners in small groups will be attached to mentors for seeking clarifications and any other help. Audio-video programmes related to practical work, which are being developed by the department, will also be provided to learners during the distance learning phase.

Contact programme consists of intensive practical training and supervised field experience in schools. Duration of contact programme would be three months. It will be followed by a period of three months of internship in actual job setting, i.e. schools, guidance agencies etc.

<sup>\*\*</sup> In-service candidates must ensure that they will attend the full-time three months' contact programme with due permission from their employers before they take admission.

#### **Medium of instruction**

The medium of instruction for the course is English and Hindi.

#### Admission procedure

Screening of candidates will be done by a committee following a selection criteria. Shortlisted candidates will take an offline selection test which includes essay writing and interview.

In-service candidates can appear in the offline selection test, if found eligible, with prior permission from their employers if deputation orders take time.

#### Course fee

Course fee to be paid by different categories of candidates is:

 Government deputed from centrally funded organisations

➤ Government deputed from State/UT departments Rs. 6,000/-

➤ Private candidates Rs.30,000/-

The expenditure for board and lodging during contact programme will have to be borne by the candidates. However, facilities for the same will be available for non-local candidates.
