विषय : प्रेरणा (PRERANA) : अनुभवात्मक शिक्षण कार्यक्रम के अगले चरण के पंजीकरण हेतु

भारत सरकार के शिक्षा मंत्रालय के स्कूल शिक्षा और साक्षरता विभाग ने 'प्रेरणा: अनुभवात्मक शिक्षण कार्यक्रम' (PRERANA: The Experiential Learning Programme) शुरू किया है, यह कार्यक्रम विद्यार्थियों को एक अनूठा, सार्थक एवं प्रेरक अनुभव प्रदान करने के लिए डिज़ाइन किया गया है जो नेतृत्व के गुणों और व्यक्तिगत विकास को बढ़ावा देता है। प्रेरणा (PRERANA) कक्षा IX से XII के चयनित विद्यार्थियों के लिए वडनगर, गुजरात के प्रेरणा स्कूल में आयोजित एक सप्ताह का आवासीय कार्यक्रम है। यह सर्वोत्तम श्रेणी की तकनीक और मूल्य-आधारित शिक्षा के साथ, विरासत और इनोवेशन का एक व्यापक मिश्रण प्रदान करता है। हर सप्ताह, देश भर से 20 विद्यार्थी (10 लड़के और 10 लड़कियाँ) इस बेहतरीन अनुभव में हिस्सा लेते हैं।

कार्यक्रम का अगला चरण अप्रैल 2026 में शुरू होने वाला है। विद्यार्थियों की भागीदारी के लिए पंजीकरण 1 दिसंबर, 2025 से प्रेरणा पोर्टल: <https://prerana.education.gov.in> पर खुले हैं। इच्छुक विद्यार्थी पोर्टल के माध्यम से आवेदन कर सकते हैं। चयन पोर्टल में उल्लिखित प्रक्रिया के आधार पर होगा। जानकारी <https://prerana.education.gov.in> पर उपलब्ध है।

PRERANA is a one-week residential programme conducted at the Prerana School in Vadnagar, Gujarat, for selected students of Classes IX to XII. It offers an immersive blend of heritage and innovation, powered by best-in-class technology and value-based learning. Each week, a batch of 20 students (10 boys and 10 girls) from across the country participate in this enriching experience.

The next phase of the programme is scheduled to commence in **April 2026**.
