NOTIFICATION

Subject: Provision, Procedures and norms of Continuous Professional Development (CPD) for Govt. /Government Aided/ Public Private Partnership (PPP) Schools affiliated with CBSE.

With a view to implement the recommendations under National Education Policy-2022 (NEP) with respect to Continuous Professional Development (CPD) of teachers of Govt. /Govt. aided/PPP Schools affiliated with the Board, the competent Authority of the Board has constituted a high powered committee to advise for improvement in teachers' training of Govt. /Govt. aided Schools and to put the robust system in place for providing an equal learning opportunity of teachers of Govt. /Govt. aided/ PPP Schools.

The committee has outlined the need for training of teachers Govt./Govt. aided schools affiliated with CBSE in the light of NEP-2020 and the teacher training related requirements of the Board targeting Continuous Professional Development (CPD) of teachers. It was further recommended that all teachers of Govt./Govt. aided/ PPP Schools affiliated with CBSE must undergo Capacity Building Programmes (CBPs) offered by the Training Unit/Centres of Excellence (CoEs) of the Board. The need based and futuristic programs may be offered so that the spirit of the NEP-2020 for CPD is best served. Therefore, the Competent Authority of the Board after due consideration in order to implement the recommendations of the Committee has inter-alia approved the following course of action to be taken by the Board and its Training Unit-HQ/CoEs/ACCPD-Rae Bareli for ensuring equitable training accessibility for teachers of Govt./Govt. aided/ PPP Schools affiliated with the Board according to suggestive guidelines related to the Continuous Professional Development (CPD) issued by NCERT and duly adopted & adapted by the CBSE:

- i. The training programs for teachers of Govt./Govt. aided/ PPP Schools affiliated with CBSE will be conducted initially on "No Cost Basis".
- ii. The Board will not charge any participation fee for conducting training programs for teachers of Govt./Govt. aided/PPP Schools.
- iii. The expenses on training venue, incidental expenses, material provided to the teachers', boarding & lodging of teachers, conveyance and other admissible allowances/ honorarium/ remuneration to participants/teachers' will be fully borne by the concerned State/UT Governments/Bodies/Authorities.
- iv. The training venue will be selected by the concerned State/UT Education Department with required physical and audio-video/IT infrastructure for conducting the Capacity Building Programmes (CBPs)/ other programmes by the Board.

- v. The Board will bear the expenses towards honorarium, TA/DA and other allowances to be paid to the Resources Persons and Board officers/officials deputed by the Training Unit-HQ/CoEs/ACCPD-Rae Bareli for the training programs.
- vi. Each State/UT/Body will develop a centralized annual training calendar (April to March) with specific details and required training programmes to be conducted on monthly basis, which are offered by CBSE Training Unit and share these details with their respective CoEs of the Board positively by the month of March every year.
- vii. The Training Unit of the Board/CoEs/ACCPD-Rae Bareli will take steps in coordination with State/UT Education Departments to ensure that each Govt. teachers should attend minimum 25 hours in the programmes organized by the Board or by the State Govt. or Govt. Regional Teachers Training Institutions and school shall organize remaining 25 hours of CPD in collaboration with School Complex of CBSE or in house program.
- viii. The concerned State/UT Government/ Body/ Authority will nominate a single point contact training coordinator with CBSE for conducting training programmes by the Board/CoEs/ACCPD-Rae Bareli.
- ix. The sponsoring State/UT Govt./Govt. aided/PPP Schools shall make online registration for trainings of their teachers on CBSE training portal.

These provisions, procedures and norms shall be effective from 01.04.2023.
