युवाओं को तंबाकू की लत और किसी भी अन्य मादक द्रव्यों के सेवन से रोकथाम के लिए कदम उठाना हमारी सामूहिक जिम्मेदारी है। राष्ट्रीय तम्बाकू नियंत्रण कार्यक्रम (एनटीसीपी) कार्यक्रम के अनुसरण में, स्वास्थ्य एवं परिवार कल्याण मंत्रालय, भारत सरकार ने नाबालिगों और युवाओं को तम्बाकू के सेवन से बचाने के लिए तम्बाकू मुक्त शैक्षणिक संस्थान (Tofei) दिशा-निर्देश जारी किए थे। शिक्षा मंत्रालय, भारत सरकार ने वाइटल स्ट्रैटेजीज और सोशियो इकोनॉमिक एंड एजुकेशनल डेवलपमेंट सोसाइटी (Seeds) के तकनीकी सहयोग से "Tofei कार्यान्वयन मैनुअल" विकसित किया है। इसका उद्देश्य शैक्षणिक संस्थानों को Tofei दिशा-निर्देशों का अनुपालन कराना और तम्बाकू मुक्त बनाना है।

Subject: Implementation of ToFEI Manual released by DoSEL, Ministry of Education, Govt. of India.

It is our collective responsibility to take preventive steps to protect our youth from the clutches of tobacco addiction and any other substance abuse. In pursuance of National Tobacco Control Programme (NTCP), the Ministry of Health & Family Welfare, Government of India had released the Tobacco Free Educational Institutions (ToFEI) Guidelines for safeguarding minors and youth from tobacco use. The Ministry of Education, Govt. of India has developed a "ToFEI Implementation Manual" with technical support from Vital Strategies and Socio Economic and Educational Development Society (SEEDS). The objective is to make educational institutions comply with the ToFEI guidelines and become tobacco free.
